

## **Data Management Policy:**

### **1. Data manager:**

### **4. Description of data management:**

According to Act CXII of 2011 on information self-determination and freedom of information, the participant agrees to it.

### **5. The managed data:**

- a)** Data necessary for the registration: Name, phone number, e-mail address.
- b)** Mandatory or voluntary provision of data during a cab order procedure: Name, phone number and e-mail address of the passenger. All dates and destinations provided during an order.
- c)** Personal data provided voluntarily by the user.

### **6. Purpose of data management:**

- a)** The use of the data provided at registration is the identification of the user and checking and managing their authorization.
- b)** The use of data provided during a cab order is to provide the taxi service at the time and location given by the customer. The data manager saves these data in its own closed system and their protection is guaranteed according to privacy policy of 6X6 Taxi Kft.

c) The use of data provided for a user's profile is to secure the user's comfort. Furthermore, we use the travel habits related data for statistics purposes to improve the services offered by the data manager. The data manager does not use personal data for other purposes. Personal data will be handed over to third parties only with prior permission from the user. This does not include handing over data to authorities on legal demand.

### **7. Duration of data management:**

We store the data provided compulsorily or voluntarily by the user until the user is a member of our website. After the user has initiated deletion of their profile, the data manager deletes all data necessary for the usage of the website within 5 working days.

6X6 Taxi Kft. deletes the data from their closed data system as stated in point 6a of their business regulations.

The service provider may limit the user's operations on the website provided the user does not use the website according to the General Terms and Conditions. In this case, data will not be deleted.

According to the paragraph 4 § (5) of the Town Council regulation no. 31/2013(IV.18), phone calls – including orders, their acceptances and their being forwarded to the taxi driver responsible – must be recorded in an electronic format and kept for a period of at least 3 months from being recorded.

### **8. Possibility of changes in data management policy:**

The data manager maintains the right to change the data management policy unilaterally without prior notification of the user. By continuing to use the website after the changes becoming effective, you automatically accept the modified data management policy.

### **9. User rights regarding the data management:**

Users can demand a personal notification about the management of their personal data. The user may exercise their rights in front of a legal

court according to the Data Protection Law or the Civil Law and demand the legal support of the data protection commissioner.

## **10. APPLICATION**

Data Management Policy is valid also for the Mobile Application, Mobile Ordering Application for iOS, Android and Windows platforms.

To fulfil the Data Management Policy the data

The data manager does NOT use personal data for other purposes.

Personal data will NOT be handed over to third parties.

This does not include handing over data to authorities on legal demand.
